

Declaration of Young Europeans on Youth Unemployment

On the context of the YouthProAktiv International ProAktivity Summit, the European Youth came up with the...

Declaration of Young Europeans on Youth Unemployment

Youth Unemployment causes short-term and long-term damage to societal and economic development. It devalues the full human capital of an entire generation. Therefore, we believe that providing effective solutions for this problem is to contribute decisively to the economic and social recovery of Europe as a whole.

The European Youth can and will play an indispensable role in resolving the problems afflicting our crisis-afflicted continent. This, however, requires important changes in the existing mentality and an openness to new best practices with regard to education and entrepreneurship in different countries. These changes must start in education systems, which are no longer able to respond effectively to the needs of the 21^{st} century labour market.

The desired changes leading to new paradigms can only be achieved by effective, concentrated measures and political will necessary to implement them. Consequently,



We call for a reform of the educational system which will individualise and personalise European education, making actual room for young people to discover and appreciate their own talents, boost their potential, and develop the abilities that will allow an efficient and sustainable transition from the academic to the professional life. This can be based upon good case practices of other Member States. We call for an agreement among states on a minimum of quality criteria to be implemented.

Declaration of Young Europeans on Youth Unemployment

2.

We encourage the implementation of a system of one-year mandatory internship for students prior to entering university, thus providing them with valuable and practical experience. From this system, students will draw concrete academic and professional benefits that will also help them set out an entrepreneurial path. We encourage the implementation of a system of mandatory practical experiences as part of school curriculum.

We call for the addition of a dedicated coaching role in secondary education which is not a member of the teaching staff. Tasked with guiding individual students towards their personalised development plan. This should incorporate participation of companies and entrepreneurs.

We call for an incorporation of mandatory comprehensive IT courses in the school curriculum to equip students at all levels with specific IT skills that have become basic in a digital age and essential for all entrepreneurial activity, e.g. basic programming language and mastery of mobile devices such as tablets.

We urge for improvement of language education to facilitate worldwide reallocation which may lead to global entrepreneurial mindset.






We call for a reduction of the financial risks for young entrepreneurs by broadening the tax exemptions for start-ups.

We urge a cut of all unnecessary red tape that hampers entrepreneurial dynamism and a harmonisation of the legal framework for start-ups and SMEs in the EU Member States, thus facilitating entrepreneurial mobility.

We advocate for the introduction of "Second-Chance Allowance", i.e. allowances for people who became bankrupt during their efforts for starting a business.

We encourage the setting of a minimum threshold of co-working spaces in European countries. These spaces will be co-financed by the EU and made available for all entrepreneurs.

We call for the immediate beginning of "quality internships" supported by initiatives and platforms with proven success. We call for the immediate end of professional unpaid internships.

We believe that the only viable option to effectively tackle the structural problem of youth unemployment depends upon the implementation of structural measures that can effectively establish an entrepreneurial mindset in Europe.

Confident that these proposed actions are all conductive to a desired change in the existing paradigms from which Europe as a whole will benefit, we share the belief that they ought to be addressed urgently and the time to do so is now, not tomorrow.



The Asia-Europe Meeting (ASEM) is an intergovernmental forum for dialogue and cooperation which fosters political dialogue, reinforces economic cooperation, and promotes collaboration in other areas of mutual interest.

ASEM was officially established in 1996 at the first summit in Bangkok, Thailand, as an exclusively Asian-European forum to enhance relations and various forms of co-operation between the then 12 members of the European Union (EU) and its Commission, the 10 members of the Association of Southeast Asian Nations (ASEAN), and the individual countries of China, Japan, and South Korea.

ASEFYLS

Inside the context of the Asia-Europe Meeting, the first ASEF Young Leaders Summit was conceived and performed!

And YouthProAktiv was there!

After several series of enlargements, ASEM currently has 53 partners: 51 countries and 2 international organisations. The countries are Australia, Austria, Bangladesh, Belgium, Brunei Darussalam, Bulgaria, Cambodia, China, Croatia, Cyprus, the Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, India, Indonesia, Ireland, Italy, Japan, Kazakhstan, the Lao PDR, Latvia, Lithuania, Luxembourg, Malaysia, Malta, Mongolia, Myanmar, the Netherlands, New Zealand, Norway, Pakistan, the Philippines, Poland, Portugal, Romania, the Russian Federation, Singapore, Slovakia, Slovenia, Korea, Spain, Sweden, Switzerland, Thailand, the United Kingdom and Viet Nam, while the European Union and the ASEAN Secretariat are the international organisations involved.

In general, the process is considered by the parties involved to be a way of deepening the relations between Asia and Europe at all levels, which is deemed necessary to achieve a more balanced political and economic world order. The process is enhanced by the biennial meetings of Heads of State and Government, alternately in Europe and Asia, and biennial meetings of Foreign Ministers as well as political, economic, and socio-cultural meetings and events at various levels.

The ASEF Young Leaders Summit (#ASEFYLS) was taking place from last 1-5th November 2015 in Luxembourg! ASEFYLS emerged from the request by young citizens and ASEM Head of States and Governments for a closer interaction and exchange of perspectives on pressing societal issues in both regions. It has been a common space for young thinkers and doers to guestion and explore how the entrepreneurial vein can trigger and nourish job-creation, mobility and social cohesion in Asia and Europe. Constructive dialogue, hands-on skills development and a Call for Action addressed to the ASEM Foreign Ministers has been the core elements of the programme.

In order to make sure that civil society is properly heard and represented in the decision making sphere, YouthProAktiv is constantly present at the European Parliament in oder to promote proactivity at and entrepreneurship. Our main aims at the European level include:





PROMOTING A PRESON-CENTERED EDUCATIONAL SYSTEM

YouthProAktiv advocates for a person-centered approach to education. We believe that education should be a platform for young people allowing them to discover their talents and skills. We aim to introduce obligatory personality tests for young people in order to encourage them to invest some time in personal development. This approach will enhance their career choices and allow them to unfold their enormous potential hidden in each person.

FIGHTING OVERREGULATION

2.

We promote the idea of economy that would allow proactive individuals to create jobs for themselves and others. We fight against unnecessary regulations which increase the costs for entrepreneurs to employ new people. We promote a vision of a balanced economy which includes regulations on issues which are absolutely necessary, and leave legal and economic space for entrepreneurs to operate.

PROMOTING LIBERALIZATION OF THE COMMON MARKET

We believe that less barriers to trade can increase the welfare of nations. In Europe a lot of these aims have already been achieved through the establishment of the common market with the freedom of movement of people, capital, services and stock. Nonetheless, in reality there is a lot of things to be improved especially in the field of services.

LOWER TAXES



YouthProAktiv is supporting all solutions which reduce unnecessary taxation for entrepreneurs. We believe that less taxes for pro-active people means more jobs for everybody.

EMPL

The EMPL Committee is mainly responsible for employment policies and all aspects of social policy, working conditions, vocational training and the free movement of workers and pensioners.

During this legislative term, these areas cover a broad range of activities, such as the fight against unemployment, in particular youth unemployment, the fight against precarious jobs, the tackling of situations of abuse, such as undeclared work or the circumvention of laws designed at protecting employees, or the improvement of rules on health and safety at work.

CULT

The Committee on Culture and Education is responsible for all the cultural aspects of the Union such as the dissemination of culture, cultural heritage, cultural and linguistic diversity, as well as for education, the audiovisual policy, the cultural and educational aspects of the information society, youth and sports. The Committee is responsible for the 'Erasmus +' programme for education, training, youth and sport, 'Creative Europe' which supports European cultural and creative sectors and the 'Europe for citizens' programme.

ITRE

The aim of the ITRE Committee is to bring the European economy back on the growth track. For that, the ITRE committe is concentrated in four priority areas». First of all, to ensure that EU's legal and economic framework enables the European industrial sector to become more innovative. Secondly, EU's policies must boost the development and growth of European small and medium-sized enterprises. Helping strengthen SMEs is as much about financing, as about openness of research programs, skills-development training schemes, or fiscal legislation. Thirdly, to build a true European digital market. And finally, to explode the full potential of EU's common energy policy.

ECON

The Committee on Economic and Monetary Affairs is responsible for Economic and monetary Union (EMU), the regulation of financial services, the free movement of capital and payments, taxation and competition policies, and the international financial system.



European Commission StartUp Europe

Startup Europe (European Commission) aims to strengthen the business environment for web and ICT entrepreneurs so that their ideas and business can start and grow in the EU. Startup Europe contributes to the Entrepreneurship 2020 Action Plan.

Startup Europe's objectives are:

. To reinforce the links between people, business and associations who build and scale up the startup ecosystem (e.g. the Web Investors Forum, the Accelerator Assembly, the Crowdfunding Network ...)

The EU-US Leadership program is designed to identify the brightest young people from the European Union and United States willing to participate in developing strong Transatlantic relations. The program allows students from both sides of the Atlantic to undergo a 3 months internship at United States Congress for European students, and at the European Parliament for American participants.





The EU-ASIA Platform for exchange of good practices is a transcontinental network of young leaders, entrepreneurs and educators from EU and Asia that aims at deepening the relations between both continents on entrepreneurship and education relatedissues.
